ITEM 7. EXECUTIVE DIRECTOR'S REPORT

Remarks by Brian Cox, Interim Executive Director, Port of South Louisiana

First, I want to sincerely thank you for the opportunity to serve as Interim Executive Director of the Port of South Louisiana. It is an honor to continue my career in public service in this capacity, and I look forward to working collaboratively with each of you to advance the mission of the Port.

Last month, Chairman Murray, our Team and I had the honor of hosting representatives from the U.S. Army Corps of Engineers, the Office of Management and Budget, and the Pontchartrain Levee District. Their visit underscored the importance of our infrastructure and flood protection initiatives, and we are grateful for their continued engagement.

Additionally, our Team met with Representative Ken Brass and regional stakeholders to discuss key infrastructure projects that will shape the future of our region. These conversations are vital to ensuring alignment and momentum across all levels of government and industry.

Mr. Quezaire and I attended a co-sponsored lunch by the Donaldsonville Chamber and Baton Rouge Industrial Group where the Governor spoke about the strength of our region and the growth we are experiencing.

I had the opportunity to provide a State of the Port presentation to the St. James Parish Council. Commissioners Bazile & Leblanc attended along with Roy Quezaire & Micah Cormier.

I'd like to recognize our Chief Commercial Officer, Micah Cormier, who was recently appointed by Governor Jeff Landry to the Louisiana Board of International Commerce. This is a significant achievement and a testament to Micah's leadership and commitment to advancing Louisiana's global trade presence.

At last week's Louisiana Board of International Commerce (LaBIC) meeting, we discussed Louisiana Economic Development's new approach to attracting foreign direct investment. The Port of South Louisiana is proud to be a partner in this effort. With our available land and strategic location, we are well-positioned to attract major global investment and support the state's economic development goals. Yesterday, Roy Quezaire, Micah and I met with the DOTD Secretary Glenn Ledet, Commissioner Julia Cormier and RPC Representatives to discuss the I-10 Reserve Interchange. This long-planned project remains a top priority for public safety, fuel efficiency and economic development. As of yesterday the Governor has elevated Julia Cormier to the role of Deputy Secretary of DOTD, tasked with making the Department run more efficiently. There is no doubt she will do great!

We're also pleased to share that Baumer Foods has officially expanded their footprint and now occupies 100% of the building they lease at Globalplex. This expansion reflects their long-term commitment to the site and ensures a strong partnership through 2029—and hopefully well beyond.

Regarding the Hyundai project, we've received word from (LED) Louisiana Economic Development that they will begin hosting monthly strike meetings to keep the project moving forward. Micah Cormier and Max Nassar of WSP will represent the Port in these sessions, ensuring our interests are well represented and progress continues.

Micah and I recently met with Associated Terminals to begin what we believe will be a historic partnership. Together, we're developing a unified approach to attracting business and cargo to Globalplex. By working collaboratively, we can increase volumes and welcome companies from around the globe who want to move cargo on the Mississippi River.

Finally, I also want to highlight a recent article in *The Times-Picayune* that showcased the unified marketing strategy launched by five of Louisiana's ports. The piece did an excellent job of illustrating how our Port is leading the way in this new collaboration, reinforcing our role as a driving force in regional and international commerce.
